1.0 INTRODUCTION

This strategic framework charts a clear path for the next quarter-century, harnessing our resources, talents, and partnerships to secure our sovereignty and elevate the well-being of every citizen. At the heart of our priorities lies the modernisation and right-sizing of our armed forces under strong civilian oversight to ensure accountability, transparency, and alignment with our democratic values.

Sustainable economic development and diversification are also crucial to reducing vulnerability and creating prosperity that reaches every community. We will pursue regional peace and cooperative diplomacy, building partnerships that advance stability within our environment and beyond. Investing in human capital, through universal access to quality health care, education and basic social services, will empower our people and secure our future. The commitment to environmental sustainability and prudent resource management, ensuring that the wealth of Ruekehi's land and natural heritage is preserved for generations to come is also our national interest.

4.0 NATIONAL STRATEGIC OBJECTIVE

Our national strategic objective is to secure Ruekehi's sovereignty, territorial integrity, prosperity, and social cohesion by 2050 through a balanced approach to peace, inclusive economic growth, responsive governance, and strong alliances.

5.0 NATIONAL STRATEGIC VISION

Ruekehi's national strategic vision provides the blueprint for our long-term aspirations, reflecting our aspirations for economic growth, social progress, and political stability. It offers a unified direction for national policies and programmes, fostering cohesion among government agencies, the private sector, and citizens. Our strategic vision is:

To guide Ruekehi through transformative reforms that strengthen national unity, expand economic opportunities, safeguard security, deepen democratic governance, and honour our domestic and international legal commitments. We will empower citizens, modernise institutions, and forge strategic partnerships.

7.0 CORE PILLARS AND ENABLING OBJECTIVES

Our vision rests on five core pillars and their enabling objectives to steer policy design, programme selection and resource allocation. Together they ensure measurable progress in peace and security, economic transformation, social development, good governance and regional leadership within our financial and legal constraints.

7.1 Peace and Security

a. Neutralise internal threats and dismantle organised crime.

- b. Protect borders through modern surveillance and regional cooperation.
- c. Strengthen the rule of law via internal security and judicial reform.
- d. Deepen counterterrorism alliances with regional and international partners.
- e. Implement defence reform to modernise and right-size the armed forces in line with genuine threat assessments.

7.2 Economic Transformation

- a. Broaden the economic base by expanding into technology and light manufacturing.
- b. Build and maintain infrastructure to connect markets, stimulate trade, and attract investment.
- c. Support small and medium enterprises, entrepreneurship and job creation through targeted initiatives and incentives.

7.3 Social Development

- a. Ensure universal access to quality health care and education.
- b. Strengthen health-system resilience to prevent and respond to major communicable-disease threats.
- c. Invest in youth skills, civic education, and digital literacy.
- d. Promote gender equality and social inclusion.
- e. Review public curricula, symbols, and cultural programmes to eliminate remnants of colonial rule and promote a shared national identity.
- f. Ensure environmental sustainability through prudent resource management and conservation measures.
- g. Leverage sustainable development to enhance national security by integrating climate adaptation, economic inclusivity and community resilience initiatives.

7.4 Good Governance and Statecraft

a. Strengthen public-sector capacity and integrity through civil-service reform, merit-based recruitment and strict anti-corruption measures.

- b. Enhance civilian oversight of the military by enacting legislation that empowers Parliament's Defence Oversight Committee and establishes clear command-and-control structures under elected officials leadership.
- c. Enhance executive, legislative, and diplomatic capacities through targeted training, institutional reforms, and resource provision.
- d. Deepen democratic governance through electoral, party-system and decentralisation reforms and digitise public services to improve efficiency, accountability and citizen engagement.
- e. Introduce programme-based, multi-year budgeting that rationalises expenditure, bolsters revenue mobilisation and restores fiscal balance, limits spending growth, prioritises capability over force size and ensures full transparency in procurement and finance.
- f. Ensure that all government actions adhere to constitutional law, statutory regulations, international conventions and treaties.

7.5 Diplomacy and Regional Cooperation

- a. Support sub-regional security frameworks and peacekeeping initiatives.
- b. Forge alliances that deter aggression, counter transnational threats, and foster economic growth ties.
- c. Host multilateral dialogues regarding the sharing of resources for refugee management and regional cooperation development.
